THE FOUNDATION FOR A SMOKE-FREE WORLD ("FOUNDATION") WAS CREATED IN 2017 WITH THE PURPOSE OF IMPROVING GLOBAL HEALTH BY ENDING SMOKING IN THIS GENERATION.

DURING ITS THIRD FULL YEAR OF OPERATION, 2020, THE FOUNDATION BUILT ON ITS ACHIEVEMENTS AND CONTINUED PROGRESS TOWARD REACHING AND SUSTAINING ITS GOAL. THE FOUNDATION'S PROJECTS ADDRESS EACH OF ITS THREE CORE PILLARS:

- HEALTH, SCIENCE, AND TECHNOLOGY: THE FOUNDATION SEEKS TO SUPPORT AN ACCELERATION OF ADULT QUITTING AND SWITCHING TO TOBACCO HARM REDUCTION PRODUCTS THROUGH RESEARCH, ADVOCACY, AND EDUCATION. RESEARCH AIMS TO: UNDERSTAND THE MOTIVATIONS OF INDIVIDUAL SMOKERS AND BARRIERS TO QUITTING; ASSESS THE EFFECTIVENESS AND SAFETY OF CESSATION AND TOBACCO HARM REDUCTION; DEVELOP MORE EFFECTIVE INTERVENTIONS (INCLUDING REGULATORY POLICIES); AND IDENTIFY BETTER BIOMARKERS OF EXPOSURE AND OUTCOMES. THE FOUNDATION FOCUSES ON BUILDING CAPACITY FOR RESEARCH TARGETING LOW- AND MIDDLE-INCOME COUNTRIES, WHERE MOST SMOKERS LIVE AND WHERE FUNDING FOR TOBACCO CONTROL RESEARCH REMAINS LACKING. ADDITIONALLY, THE FOUNDATION SUPPORTS THE DEVELOPMENT OF INTERACTIVE DIGITAL PLATFORMS TO OFFER RESEARCHERS AND POLICY MAKERS INSIGHTS RELATED TO PUBLIC PERCEPTIONS, SCIENTIFIC OUTPUT, AND PATENTS RELATED TO CESSATION AND TOBACCO HARM REDUCTION.
- AGRICULTURE TRANSFORMATION: THE FOUNDATION IS PREPARING FOR A FUTURE OF REDUCED TOBACCO DEMAND. ITS GOAL IS TO MAKE THE AGRICULTURE SECTOR GLOBALLY MORE COMPETITIVE BY WORKING WITH SMALLHOLDER TOBACCO FARMERS TOWARD THE DEVELOPMENT OF NEW BUSINESS MODELS THAT CREATE VALUE FOR PARTICIPANTS CURRENTLY DEPENDENT ON THE TOBACCO SUPPLY CHAIN. THIS WORK HAS STARTED IN MALAWI. TO ACHIEVE ITS MISSION, THE FOUNDATION IS PARTNERING WITH THE PRIVATE SECTOR, SMALLHOLDER FARMER ORGANIZATIONS, GOVERNMENT, LEADING NATIONAL AND INTERNATIONAL AGRICULTURAL RESEARCH GROUPS, AND FINANCIAL STAKEHOLDERS. IN COLLABORATION WITH THESE GROUPS, THE FOUNDATION AIMS TO CATALYZE INVESTMENT, DEVELOP AND STRENGTHEN EXTENSION SERVICES BASED ON AGRO-SCIENCE, AND PROMOTE ENTREPRENEURSHIP TO SUPPORT TOBACCO FARMERS IN THEIR TRANSITION TO ALTERNATIVE CROPS AND LIVELIHOODS.
- INDUSTRY TRANSFORMATION: THE FOUNDATION'S INDUSTRY TRANSFORMATION EFFORTS FOCUS ON MONITORING AND PROMOTING CHANGE ACROSS THE GLOBAL TOBACCO AND NICOTINE ECOSYSTEM, WITH THE GOAL OF ENDING COMBUSTIBLE USE. THE TOBACCO TRANSFORMATION INDEX, WHICH IS THE FIRST ACTION OF THE FOUNDATION'S INDUSTRY TRANSFORMATION INITIATIVE, PROVIDES OBJECTIVE DATA ON WHETHER COMPANIES ARE TRANSFORMING THEIR CORE BUSINESS MODELS TO ACCELERATE THE REDUCTION OF HARM CAUSED BY TOBACCO

USE. THE INDEX RANKS THE WORLD'S 15 LARGEST TOBACCO COMPANIES ON THEIR RELATIVE PROGRESS TOWARD HARM REDUCTION.

EMBEDDED IN ALL OF THESE PRINCIPLES AND PROJECTS IS THE FOUNDATION'S COMMITMENT TO GENDER EQUALITY AND THE APPLICATION OF A COMPREHENSIVE GENDER PERSPECTIVE.

ARTICLE THIRD OF THE FOUNDATION'S CERTIFICATE OF INCORPORATION SPECIFIES USE OF ASSETS OR INCOME TOWARD SEVEN SETS OF ACTIVITIES. THE FOUNDATION IS DEMONSTRATING PROGRESS IN SIX OF THE SEVEN SMOKE-FREE PURPOSES: HEALTH, SCIENCE, AND TECHNOLOGY ADDRESSES SMOKE-FREE PURPOSES (I), (II), (III), AND (VII); AGRICULTURE TRANSFORMATION ADDRESSES SMOKE-FREE PURPOSE (V); INDUSTRY TRANSFORMATION ADDRESSES SMOKE-FREE PURPOSE (IV); AND SMOKE-FREE PURPOSE (VI), RELATED TO ENVIRONMENTAL ISSUES, WILL BE ADDRESSED AT A LATER DATE.

DURING 2020, THE FOUNDATION DISTRIBUTED GRANT PAYMENTS TOTALING \$25.5 MILLION IN SUPPORT OF ITS THREE CORE PILLARS AND PURPOSES. THE FOUNDATION HAS COMMITTED TO MORE THAN \$120 MILLION IN CONDITIONAL GRANTS THROUGH 2024 AND WILL CONTINUE TO ADD TO THOSE COMMITMENTS OVER TIME. DIRECT CHARITABLE ACTIVITIES IN 2020 SUPPORTED EACH OF THE THREE MAIN AREAS OF THE FOUNDATION'S STRATEGIC PLAN. EACH STRATEGY MAY FUND GRANTS AS WELL AS INCUR EXPENSES:

- HEALTH, SCIENCE, AND TECHNOLOGY: (EXPENSES OF \$17,693,441, INCLUDING GRANT EXPENDITURES OF \$11,966,470).
- AGRICULTURE TRANSFORMATION: (EXPENSES OF \$8,518,160, INCLUDING GRANT EXPENDITURES OF \$4,538,499)
- INDUSTRY TRANSFORMATION: (EXPENSES OF \$3,459,954, INCLUDING GRANT EXPENDITURES OF \$2,938,712)

IN CONCERT WITH ITS RESEARCH INITIATIVES, THE FOUNDATION FUNDED CHARITABLE ACTIVITIES IN 2020 TO ENHANCE COMMUNICATIONS AND EDUCATION RELATED TO ENDING SMOKING. THESE ACTIVITIES ALSO AIMED TO ASSESS POLICIES THAT REFLECT THE RELATIVE RISK OF TOBACCO AND NICOTINE PRODUCTS (EXPENSES OF \$6,268,654, INCLUDING GRANT EXPENDITURES OF \$3,761,811).

IN ADDITION, GRANTS FOR CHARITABLE PURPOSES WERE MADE TO PROVIDE HUMANITARIAN ASSISTANCE IN LIGHT OF THE COVID-19 PANDEMIC (EXPENSES OF \$2,134,982, INCLUDING GRANT EXPENDITURES OF \$2,129,507).

TOTAL DIRECT CHARITABLE ACTIVITIES ACROSS THE FOUNDATION'S PROGRAMS TOTALED \$38.1 MILLION IN 2020.

ONE OF THE GAPS IN TOBACCO CONTROL THAT THE FOUNDATION ADDRESSES IS IMPROVING PUBLIC AWARENESS OF THE DRIVERS OF SMOKING HARM AND THE AVAILABILITY OF ALTERNATIVES. THE FOUNDATION'S GOAL IN LEVERAGING PUBLIC RELATIONS SUPPORT IS TO EDUCATE THE PUBLIC ABOUT THE NEED FOR COLLABORATION, INNOVATION, AND TOOLS THAT CAN HELP SMOKERS QUIT OR REDUCE THEIR RISK.

IN 2020, THE FOUNDATION'S PUBLIC RELATIONS EFFORTS SUPPORTED THE DISSEMINATION OF THE RESEARCH RESULTS FROM ITS HEALTH, SCIENCE, AND TECHNOLOGY GRANTEES AND RESEARCHERS. THE FOUNDATION USED ITS DIGITAL CHANNELS TO DRIVE AWARNESS OF KEY GLOBAL STATISTICS AND REPORTS ON SMOKING BEHAVIORS, HARM REDUCTION, AND SMOKING CESSATION. AS THE AGRICULTURE TRANSFORMATION WORK IN MALAWI MOVED INTO ITS THIRD YEAR, PUBLIC RELATIONS AND COMMUNICATIONS ON SOCIAL CHANNELS RAISED AWARENESS OF THE ISSUES FACING SMALLHOLDER TOBACCO FARMERS. 2020 COMMUNICATIONS EFFORTS RELATED TO INDUSTRY TRANSFORMATION FOCUSED ON THE LAUNCH OF THE FIRST TOBACCO TRANSFORMATION INDEX.

THE BREAKDOWN OF COMMUNICATIONS EXPENSES IN 2020 ACROSS THE FOUNDATION'S STRATEGIES IS ESTIMATED AS FOLLOWS: HEALTH, SCIENCE, AND TECHNOLOGY, 70%; AGRICULTURE TRANSFORMATION, 5%; INDUSTRY TRANSFORMATION, 15%; GENERAL EDUCATION & AWARENESS, 10%. (EXPENSES OF \$3,346,332)

(AMOUNTS PAID TO ACQUIRE ASSETS AND EXPENSES: \$2,035,000)

THE FOUNDATION CONTRACTED WITH SEVERAL ORGANIZATIONS TO CONDUCT AND DOCUMENT RESEARCH IN SUPPORT OF THE FOUNDATION'S CHARITABLE PURPOSES IN THE AREAS OF HEALTH, SCIENCE, AND TECHNOLOGY, AGRICULTURE TRANSFORMATION, AND INDUSTRY TRANSFORMATION. PROJECTS INCLUDE: COVID-19 STATE OF SMOKING POLL; WOMEN AS LEVERS OF CHANGE IN MALE-DOMINATED INDUSTRIES, INCLUDING TOBACCO; REVIEW OF VIABLE VALUE CHAINS IN MALAWI, INCLUDING THE PERSPECTIVE OF GENDER AND INCLUSIVE VALUE CHAINS; INDIA'S WOMEN BEEDI ROLLERS AND ALTERNATIVE LIVELIHOOD OPTIONS; REPORTS ON DEVELOPMENTS IN AND ECONOMICS OF TOBACCO HARM REDUCTION; REVIEW OF SOCIO-ECONOMIC AND POLICY CONDITIONS THAT INCENTIVIZE FARMERS TO DIVERSIFY FROM TOBACCO; AND SUMMARY OF EXPERT

CONTRIBUTIONS ON REGULATORY ISSUES, TAXATION, AND OTHER PERSPECTIVES IN TOBACCO HARM REDUCTION. (EXPENSES: \$724,348)

THE FOUNDATION EMPLOYED ORGANIZATIONS TO DESIGN, DEVEOP, AND TRANSLATE ITS DISSEMINATION PLATFORMS, INCLUDING WEBSITES ASSOCIATED WITH THE FOUNDATION FOR A SMOKE-FREE WORLD, TOBACCO TRANSFORMATION INDEX, AND UNDERSTANDING NICOTINE. (EXPENSES \$644,056)
